Minutes of the Annual Business Meeting of CAANS held at 3.45 p.m. on May 31, 1997, at the Learned Societies, Memorial University.

- 1. The required quorum of 10 members in good standing were present.
- The minutes of the annual meeting held at Brock University on June 1, 1996 having been distributed to all members in the Newsletter of August 1996, Beert Verstraete moved to accept the minutes. Seconded by Basil Kingstone and Gerrit Gerrits, and carried.
- 3. In his report the President expressed pleasure at the good attendance at this conference notwithstanding the remoteness of the site. He was very grateful for the participation of Jaap Tuinman, Vice-President Academic of Memorial, as keynote speaker. After an uncertain start 27 years ago at Acadia University, CAANS/ACAEN has developed into an association with distinctive interests, benefiting both Canadian and Dutch communities. Herman van Wermeskerken moved to accept the report of the President. Seconded by Gerrit Gerrits and Tineke Hellwig, and carried.
- 4. The Vice-President and Program Chair reported that she enjoyed establishing the program, and remarked on the great possibilities for CAANS after 26 years, and especially on the goodwill that she had experienced. However, she saw the need for a membership drive. Basil Kingstone moved to accept her report. Seconded by HennyRuger and Gerrit Gerrits, and carried.
- 5. The Secretary-Treasurer reported on correspondence received:
 - Dr. Embert van Tilburg of Victoria, B.C. asked for and was sent information on CAANS with a view to establishing a chapter in Victoria.
 - b. CANCOPY asked CAANS to become a member. There is no membership fee. Benefits are income from copyright. For 1996 and 1997 we received a total of \$523.00. An application for membership will be submitted.
 - c. The Humanities and Social Sciences Federation of Canada (HSSFC) mailed a brochure about their activities and invited CAANS to join. Liabilities for CAANS: circa \$1,750.00 per year. Benefits: \$600.00 support per conference plus \$6.60 for each member attending, in total an average of \$850.00 per year. Membership of HSSFC will not be applied for.

He also presented the Treasurer's Report for 1996, the interim statement for the first quarter of 1997 and the budget for the year 1997 (they are all in this Newsletter), with the following comments:

- a. There was a small budget overrun mainly due to conference costs levied by HSSFC.
- b. Donations from the Dean of Arts of the University of Windsor and the Nederlandse Taalunie, and a postage refund from Heritage Canada, closed the budget gap in the year 1996.

Basil Kingstone moved to accept the reports of the Secretary/Treasurer. Seconded by Beert Verstraete and Henny Ruger, and carried.

Following a discussion on fundraising, three proposals were tabled:

- a. The President is to approach the Nederlandse Taalunie to obtain a structured yearly grant.
- b. The President is to approach the Netherlands Embassy in Ottawa to seek support for CAANS' endeavours in reaching teachers of the Dutch language via the Newsletter.

c. A committee consisting of Basil Kingstone, Joan Magee and Beert Verstraete is to be appointed with the purpose of increasing the membership of CAANS.

Basil Kingstone moved to accept the three proposals. Seconded by Beert Verstraete and Herman van Wermeskerken, and carried.

The Secretary-Treasurer moved to raise the membership fee. Seconded by Tineke Hellwig and Alexander Zweers. With a subsequent motion (Verstraete/Kingstone, van Wermeskerken), the new annual membership fee scale was established at: regular members (including institutions) \$25.00; seniors \$20.00; students \$15.00.

The Secretary/Treasurer moved to establish a fund for donations by the members, which would be used to aid students who come and read papers to the CAANS conferences. Donations are tax deductible. The Treasurer has already collected \$200.00 for this purpose. Seconded by Joan Magee and Henny Ruger, and carried.

6. The Editor reported that the 1996 special issue of the Journal has finally gone to the printer. The 1997 spring issue is almost ready. He has applied to Heritage Canada for special postal rates which would be more advantageous than the present refund system; they could reduce mailing costs by as much as 75%. Martin Bakker has retired and chosen to step down from the Editorial Board. [Hermina Joldersma has kindly agreed to replace him. -Ed.] Those who read papers to the 1997 conference were warmly encouraged to submit them to be considered for publication.

Tineke Hellwig moved to accept the Editor's report. Seconded by Beert Verstraete and Alexander Zweers, and carried.

- Ton Broos announced the 11th Biennial Conference of the Association for Dutch-American Studies on June 12 and 13 at Hope College in Holland, Michigan. Ton agreed to be CAANS' liaison person with AANS.
- 8. There was no Toronto representative of the Language Committee present to give a report.
- All members of the Executive were willing to continue in office except Herman van Wermeskerken, who is stepping down after four years. Gerrit Gerrits agreed to take over as Secretary/Treasurer. No other nominations being received, Tineke Hellwig moved to elect the reconstituted Executive. Seconded by Alexander Zweers and Ton Broos, and carried.
- In 1998 the Learned Societies will be reborn as the Congress of the Social Sciences and Humanities, to be held at the University of Ottawa from 27 May to 6 June. CAANS will ask to meet on a weekend as usual, namely May 30 and 31.
- In his closing remarks, Beert Verstraete expressed his gratitude to Joan Magee for her effort in organizing the conference, and to Herman van Wermeskerken for the professional way in which he has conducted his business as Secretary/Treasurer. He moved to adjourn. Seconded by Ton Broos and Gerrit Gerrits, and carried.

Minutes of the Annual Meeting of CAANS, held at the HSSFC Congress (formerly the Learned Societies), in room MRT 015 at the University of Ottawa at 4 p.m. on Sunday May 31, 1998.

- 1. The required quorum of ten members in good standing was present.
- The minutes of the Annual Meeting held at Memorial on May 31,1997 were approved with one correction: Acadia University should read Memorial University (Kingstone/Magee, unanimous).
- 3. The President, Beert Verstraete, gave his report. He thanked Mieke Bos of the Dutch Embassy, whose tour of duty in Ottawa is ending, for all her work on our behalf, including obtaining support for the 1996 special issue of the Journal. He also thanked the Taalunie (two representatives of which, Elisabeth d'Hallewyn and Jacqueline Balteau, were present), for their generous financial support, and the University of Windsor for its ongoing support of the Journal. He and Richard Unger adjudicated the "Canada-Holland: My Vision" essay contest. There were not many candidates, but there would no doubt be more in future.

He noted that he had received a letter about the proceedings of the Toronto chapter, which now has fifty members. The Vancouver chapter is even larger. These were encouraging signs.

The President's report was adopted (van Wermeskerken/Kingstone, unanimous).

- 4. The Vice-President, Joan Magee, reported that the Belgian community are again, after some years, very interested in CAANS. They have a web site with information which could be of interest to our members. We should have a site, which should include a brochure like that of the Canadian Association for Scandinavian Studies. We could thus attract writers, musicians and other speakers to our meetings. The Vice-President's report was approved (Dierick/van Wermeskerken, unanimous).
- 5. Basil Kingstone reported for the Secretary-Treasurer, Gerrit Gerrits, presenting the financial statement, then for himself, about the Journal and Newsletter. The two subjects, of course, interrelate. The balance of \$6,600.08 almost equals the cost of printing and mailing the 1997 issues of the journal. The Fall 1997 and Spring 1998 issues are in preparation. It is not yet known if the Dean of Arts (now Dean of Arts and Human Sciences) at the University of Windsor will renew her annual grant.

Basil Kingstone's reports were adopted (Vorst/Dierick, unanimous).

6. The question of joining the HSSFC was revisited. The cost is \$5 or \$6 per member, and for non-member organisations there is a \$6 charge for everybody who attends the Congress. Looked at that way, we would get little return for our money, though we would become eligible for grants of about \$400 to help pay for visiting lecturers. However, the federation is the chief lobbyist for the humanities and social sciences in Canada, and it was argued that we benefit from it anyway and should therefore support it.

It was agreed that Jesse Vorst would obtain more facts on which the executive could base a decision whether to recommend joining or not (Vorst/Dierick, unanimous).

- The next meeting of the HSSFC Congress is at Sherbrooke and Bishop's universities. André Petit of Bishop's has agreed to be the local representative. The two universities are ten minutes apart by shuttle bus. Perhaps we could meet for one day in each place.
- 8. Following on from 4 above, it was agreed that the committee on recruitment and fundraising should design a brochure, and open a web site to announce events, put the Newsletter on line, etc. The Belgian Embassy is prepared to help, and this arrangement would be excellent if we have constant access to keep the site up to date. Mary Nash volunteered to be in charge of updating. We can also be on the end of a hyperlink from the web site being prepared by the Dutch Embassy. Abstracts of papers for the annual conference could be put on the site too.
- 9. Elections were held for the executive. Beert Verstraete was re-elected as President, Joan Magee

as Vice-President, and Gerrit Gerrits as Secretary-Treasurer. It will be ascertained if the members at large wish to continue to serve. The proposals were adopted (Vorst/Dierick, unanimous).

10. The meeting was adjourned at 5.10 p.m.

Annual General Meeting

Held at 2 p.m. on May 28, 2000, in room ED170 at the University of Alberta. 10 members constitute a guorum, and 10 were present.

The president. Frans Schryer, gave his report. He concentrated on two financial guestions[†]:

1. The Taalunie gave us 3000 guilders in 1999 (\$2210.95) and has given us \$2000 this year. part being to bring Hans Vanacker to our congress. They would like us to coordinate our reguests for covering the costs of visiting speakers with those of the embassies or consulates, as well as with those of local chapters. We need to come up with a flexible plan and a budget.

2. The executive has decided that CAANS will not join the HSSFC, the organizers of the congress. As a nonmember organization we pay a differential fee of \$500: instead of raising it to \$900, the HSSFC decided to charge all participants in the congress \$20 per society attended. Now there is talk of putting the fee back up. The Taalunie grant includes reimbursement of this fee: Frans will ask if they will be so kind as to continue to cover this expense.

The slate of officers was refreshed. Frans has one more year to serve as president, and Gerrit has agreed to serve another term as secretary-treasurer. Alice van der Klei was acclaimed as vice-president. a post which will involve preparing the programme for the 2001 meeting at Laval University [on May 26 and 27] and being the local representative there. Frans will find out if the regional members at large wish to remain in their posts.

There was a discussion of publicity:

- Henny Ruger has prepared a pamphlet about us.
- Our table at all conferences should offer this pamphlet. a poster. and the timetable for the meeting. The local representative should ensure that all these items are on display. At certain times there should also be someone on hand to answer guestions.
- The web site. The format is in place, but a virus destroyed the content that Jennifer Gerrits had loaded. The executive is looking at other web sites of comparable organizations (e.g. the Canadian Association for Translation Studies) to see what our content should be. We invite all our members to make suggestions as to content. We felt that the site should be housed at a university rather than at a commercial company, since no matter who comes or goes, the university goes on. Frans suggested calling for tenders to determine the cost of maintaining the site, and felt the Taalunie should be asked for funding for this purpose.

It was moved (Dierick/van der Klei), and carried unanimously, that the annual general meeting endorse the creation of the web site and entrust the executive with determining the content. A vote of thanks was also moved (Magee/Kingstone), and carried unanimously, to Mary Mash for having offered to set up the site, and to Jennifer Gerrits for having set it up.

The meeting was adjourned at 3.20 p.m.

MINUTES OF THE ANNUAL MEETING OF CAANS held at 3 p.m. on May 27, 2001 at l'Université Laval in the Pavillon Casault, room 3305. This is, as Joan Magee reminded us, our thirtieth anniversary.

1. The minutes of the 2000 annual meeting were approved. The agenda was approved. It is noted that in future, copies of the previous minutes should be brought to the annual meeting and that the agenda should be published ahead of time in the Newsletter.

2. The outgoing president, Frans Schryer, gave his report. On behalf of the treasurer, Gerrit Gerrits, who could not attend, he reported that the finances were in sound shape, but that the balance was misleadingly large because publication of the Journal is behind schedule. The Taalunie has continued to support us, and we have agreed to centralize all requests for funds for visiting speakers through CAANS national; they subsidized this year Els vanTemmerman and Helen Metzelaar.

Next year we will meet at the University of Toronto and Ryerson. By then we should deal with one unfinished project, namely the website, which should be up and running. It needs a webmaster and a home on a campus.

3. The vice-president, Alice van der Klei, gave her report. She has already noticed that (as usual) HSSFC have put us down for a midweek slot next year, and got this changed to Saturday and Sunday May 25 and 26, 2002. Michiel Horn has agreed to be the local co-ordinator, since he is at York. The topic announced by HSSFC for next year is "Boundaries: Gender, Genre and Geography." It was moved (Dierick/Schryer) to thank Alice for her work in organizing the conference. Carried unanimously.

4. The editor of the Journal and Newsletter, Basil Kingstone, gave his report. Owing to pressure of teaching duties during the past year, publication of the Journal has been delayed, two newsletters have been late and one has had to be shortened. With the editor's retirement things should improve.

The Dean of Arts and Social Sciences at the University of Windsor has cut her annual grant from \$2000 to \$1000 and next year it may cease altogether.

MINUTES OF THE ANNUAL MEETING OF CAANS/ACAEN HELD AT 14:00 ON MAY 26, 2002 AT THE UNIVERSITY OF TORONTO, IN ROOM 152 OF THE UNIVERSITY COLLEGE.

1. The required quorum of ten members in good standing were present and the agenda for the meeting was approved.

 The minutes of the 2001 annual meeting, distributed in the CAANS Newsletter/ Bulletin de L'ACAEN, of August 2001 were accepted. Acceptance moved by Mary Eggermont. Seconded by Geeske de Laat and Jesse Vorst, and carried.

3. In her report the president, Mary Eggermont, expressed her pleasure in the good attendance at the 2002 conference. She was very grateful for the participation of Dick de Boer, Professor Medieval History at the University Groningen and voiced her gratitude for the support of the Nederlandse Taalunie, which enabled us to invite European speakers not only to our conference but also to the meetings of the chapters. She mentioned the establishment of the CAANS/ACAEN web site, thanks to the much appreciated effort of our webmaster Peter Lowensteyn. Herman van Wermeskerken moved to accept the report. Seconded by Jesse Vorst and Geeske de Laat, and carried.

4. The Secretary/Treasurer, Herman van Wermeskerken, submitted his financial statement over the last calendar year (attached to these minutes). To maintain the auditing trail this report is in two parts, one for each period under respectively the former and the new treasurer. He mentioned the efforts of Basil Kingstone, which resulted in grants of \$ 500.00 from the Dean of Arts of the University of Windsor and of close to \$ 7,000.00 over four years from SSHRC. Gus Dierick was instrumental in obtaining \$ 2,475.91 from the University of Toronto, put in trust and to be used for the furthering the study of the Dutch language.

Although the balance at the year's end shows a credit of almost \$15,000.00, at least \$6,500.has to be reserved for three issues of the Journal still in the process of editing. Circa \$2,500.00 is in a trust fund for special purposes.

He proposed to use the grant of SSHRC to partially reimburse the speakers at the conference, as it used to be done in the past. Basil Kingstone moved to accept the report and the proposal. Seconded by Gus Dierick and John Michielsen, and carried.

5. The Editor of the Journal, Basil Kingstone, gave his report. Vol. 21 no. 1 came out in the winter, and no. 2 was ready to go to the printer's. That still left a year's backlog, but he will have more time now to catch up. There was discussion of whether some members could receive the newsletter electronically, or could read the items on the CAANS web site if they were posted there as received, and whether other journals we received needed to be summarized or whether it would be sufficient to copy the tables of contents and give a link to them. The next newsletter will ask these questions of the members. Mary Eggermont moved to accept the report. Supported by Herman van Wermeskerken and Gus Dierick, and carried.

6. All members of the board were willing to continue in office. No nominations being received

the board is reelected for another year by acclamation.

7. The next annual meeting will take place in Halifax. Michiel Horn and Gerrit Gerrits will look after the technical details and confer with SSHRC to have the date set on the last weekend of May or the first one in June. The president and Michiel Horn will seek for a keynote speaker. A call for papers will be placed in the Newsletter/Bulletin by Basil Kingstone.

 During the meeting it seemed some details of the Constitution need to be re-addressed. Gus Dierick, Basil Kingstone and John Michielsen will convene a meeting to draft necessary changes and scrutinize our Mission Statements.

9. In her closing remarks Mary Eggermont expressed her gratitude to Michiel Horn and Basil Kingstone for their endeavour leading to a successful Annual Meeting. She moved to adjourn at 15:15. Seconded by Gus Dierick and Herman van Wermeskerken, and carried.
